THE ROLE

We're looking for two people to join our forestry team.

JOB SUMMARY

You'll be part of something unique, helping to grow and shape one of England's largest new native woodlands and a diverse range of habitats. The Forest is a home to many rare and threatened species, such as brown hairstreak and purple emperor butterflies, as well as Red List bird species such as skylark and woodcock.

You'll join our friendly and dedicated forestry team who are responsible for the management of our new woodland, and our mature and ancient woodland. You'll be mainly focused in one large area of the Forest but could also work elsewhere across the estate as required. The winter months will be predominantly focused on tree planting where you will create new woodland within the Heart of England Forest. This role is ideal for a practical person wishing to further develop their land-based forestry and conservation skills.

In this role you will work alongside the wider staff team, volunteers, corporate supporters and visitors to promote the charity and achieve our vision of a 30,000-acre broadleaf forest. If you enjoy working outdoors in all weathers, engaging with people and are passionate about woodland conservation, we would love to hear from you.





KEY RESPONSIBILITIES

PRACTICAL FORESTRY WORK

- Tree planting (throughout November to March).
- Forest establishment and maintenance work, including shelter maintenance, weeding, loss assessment, tree guard removal, etc.
- Maintaining and improving public access within the forest, which includes inspections of access areas, reporting health and safety issues, and resolving problems under own initiative.
- Emptying car park bins, dog bins and securing car parks.
- Maintaining walking routes, way-marking infrastructure, visitor information and car parks.
- Tractor driving and use of machinery including mowing forest rides, hay making and hedge cutting.

- Mowing footpaths.
- General forest maintenance work in mature woodland.
- Habitat creation, maintenance and monitoring.
- Undertaking tree tagging and mapping tree locations.
- Tree felling and extraction.
- Mentoring interns, apprentices and forest assistants.
- Leading volunteer work parties and supervising volunteers, interns and work experience students.

KEY RESPONSIBILITIES (continued)

PEOPLE ENGAGEMENT

- Providing support to deliver general volunteer and corporate volunteer work parties when needed, which may include some weekend work.
- Supporting / leading guided walks (which will include weekend and Bank Holiday working).
- Supporting educational visits where required.
- Supporting other stakeholder visits.
- Assisting with the planning and delivery of Heart of England Forest events.
- Contribute information, photos and stories for communication channels.
- Being an ambassador for the Heart of England Forest

GENERAL

- Demonstrate and promote the values of the Heart of England Forest.
- Maintain a commitment to high standards of health and safety at all times. Ensure all work is undertaken within the Heart of England Forest health and safety policy and processes.
- Play an active part within the wider Heart of England Forest team.
- Make active use of information and resources gained via personal networks to inform the development of this role.
- Perform any other duties consistent with the role and / or reasonably required by your line manager, and/or the Senior Leadership Team.

- Committed to conservation
- Full driving licence (manual)
- A flexible approach to work and willingness to undertake some evening and weekend work
- Willingness to develop new skills and take on new areas of responsibility

HOURS

Normal working hours will be 37.5 a week, usually between 08.00 and 16.30, Monday to Friday. However, some out of office hours work will be required, which may include evenings, weekends, and bank holidays, for which time off in lieu will be given.

LOCATION

You'll be based at one of our forestry hubs in Dorsington near Stratford upon Avon or Spernal. The post holder must have the willingness and ability to travel across the Heart of England Forest daily to meet the demands of the role.
