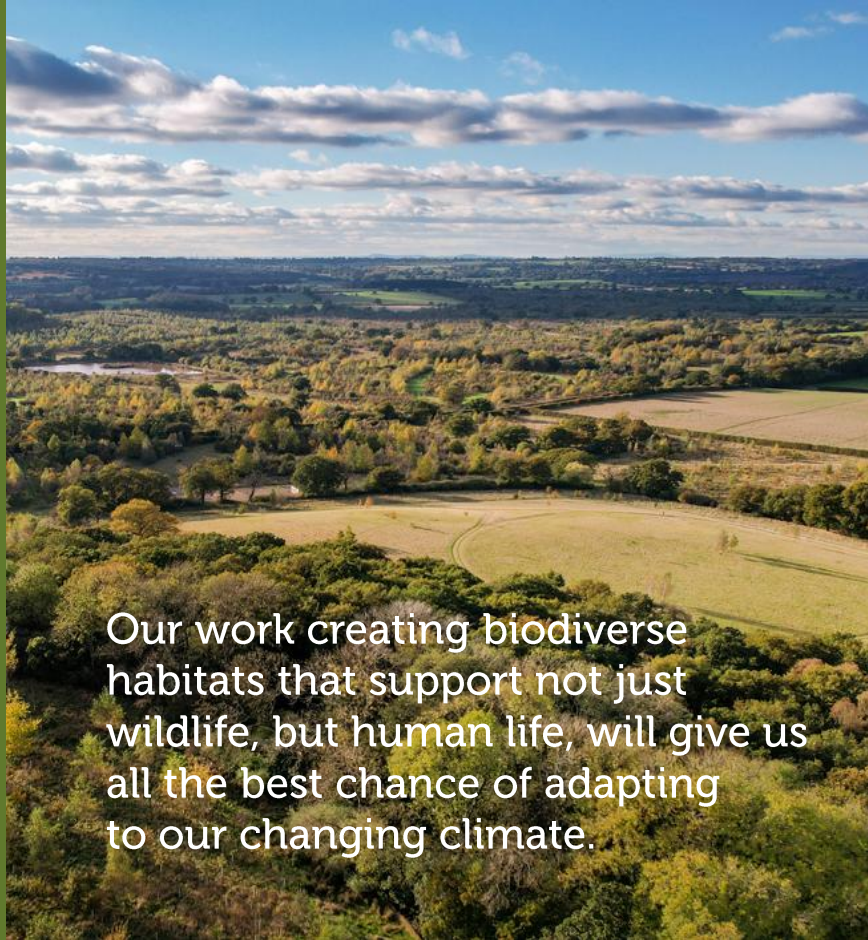
CEO WELCOME

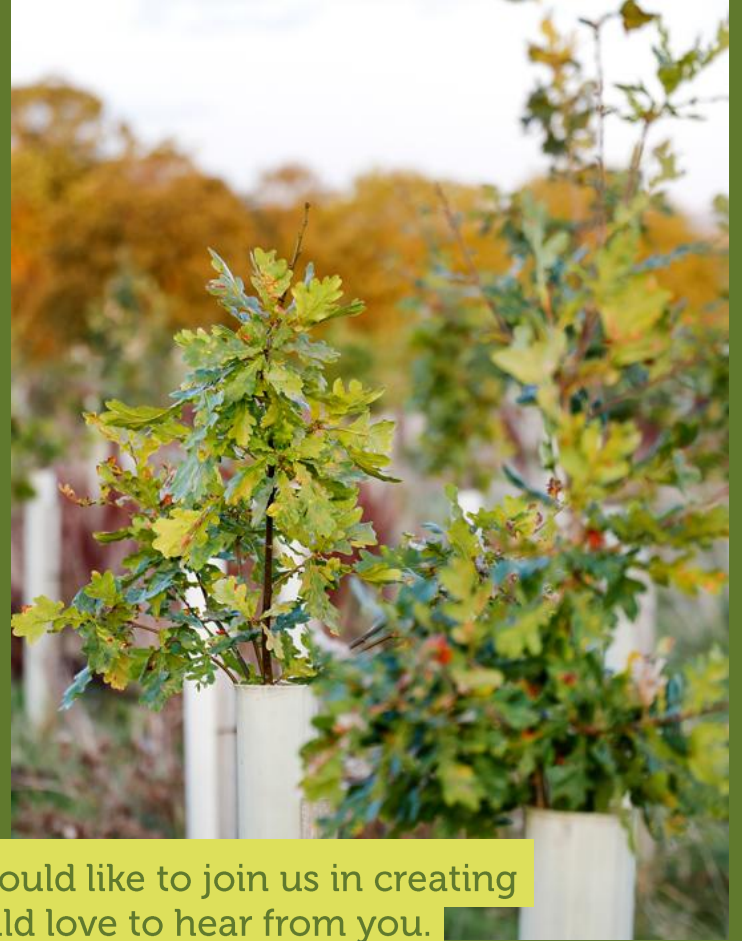
JOIN US

THE ROLE

Reporting to the Director of Forest Operations, this post will support the wider team using their technical expertise.

JOB SUMMARY

The Forest Operations Technical Lead will provide professional forestry expertise to support woodland creation and management of The Heart of England Forest estate. Overseeing operational programmes and delivery, the role will ensure best-practice woodland management, woodland creation, health and safety compliance, and adherence to the UK Forestry Standard.

The Forest Operations Technical Lead will support the Forest Operations team by managing contractor work on our sites, providing support and guidance to other team members, leading on health and safety management, and managing the Tree Nursery team, who provide a vital service of growing trees for our forest growth, as well as for sale to other organisations.



KEY RESPONSIBILITIES

FORESTRY WORK

- Support the Forestry Works Managers, and their teams, by planning and overseeing operational delivery across multiple programmes of work, including woodland creation, woodland management, wildlife management and enhancement, and tree nursery operations.
- Manage contractors from researching, tendering and appointing the correct contractors, through to ensuring they deliver works to time, cost and quality.
- Ensure the organisation has an effective Species Management Plan in place, to control deer and grey squirrels. Liaising with contractors and the Forestry Commission as required.
- Provide technical input for woodland creation and management planning, advising the Directors of Forest Operations and Land Use Policy & Planning.
- Use GIS for site mapping and surveys.

TREE NURSERY

- Line management of the Senior Tree Nursery Technicians.
- Co-ordinate the delivery of the tree nursery programme, ensuring a joined up and collaborative approach across multiple sites.
- Support the diversification of the Tree Nursery operation, ensuring that effective in-house resources and supply chains are in place at all times.
- Develop and oversee an effective system to pack and distribute stock to external clients (B2B).
- Ensure the tree nursery operation continues to meet its compliance requirements, including (but not limited to): water extraction licences (Environment Agency), Plant Healthy Scheme and Plant Passports (Animal and Plant Health Agency).

KEY RESPONSIBILITIES (continued)

HEALTH AND SAFETY / REGULATORY COMPLIANCE

- Ensure compliance with best practice health and safety procedures, using risk assessments and the Forest Industry Safety Accord (FISA) guidance to implement safe working practices.
- Supervise third party contractors and consultants, ensuring works are undertaken safely, including the production of risk assessments and method statements.
- Oversee machinery use for operational work to ensure safe working practices.
- Support the Director of Forest Operations with technical planning and reporting for regulatory compliance and audits.
- Be an active and supportive member of the Health and Safety Committee, liaising with the Chief Executive to set the agenda and proactive approach to H&S management.

OTHER RESPONSIBILITIES

- Demonstrate and promote the values of the Heart of England Forest.
- Maintain a commitment to high standards of health and safety at all times. Ensure all work is undertaken within the Heart of England Forest health and safety policy and processes.
- Play an active part within the wider Heart of England Forest team.
- Make active use of information and resources gained via personal networks to inform the development of this role.
- Perform any other duties consistent with the role and / or reasonably required by your line manager, and/or the Senior Leadership Team.

- Proven experience of health and safety management within forestry operations.
- Competence in GIS for mapping and site data recording.
- Professional member of the Institute of Chartered Foresters (ICF) or willingness to work towards chartered status.
- Valid drivers licence and willingness to work outdoors in varied conditions.

- Experience of tree nursery operations and practice.
